► **APPLICANT'S REASON FOR CHANGE:** A portion of Willow Avenue was closed, which caused the eastern and western portions of this right-of-way to be disconnected. Having non-contiguous road segments with the same street name is a safety concern for the Knox County Emergency Communications District. The name "Patton Street" was selected to retain a historic street name in this community.

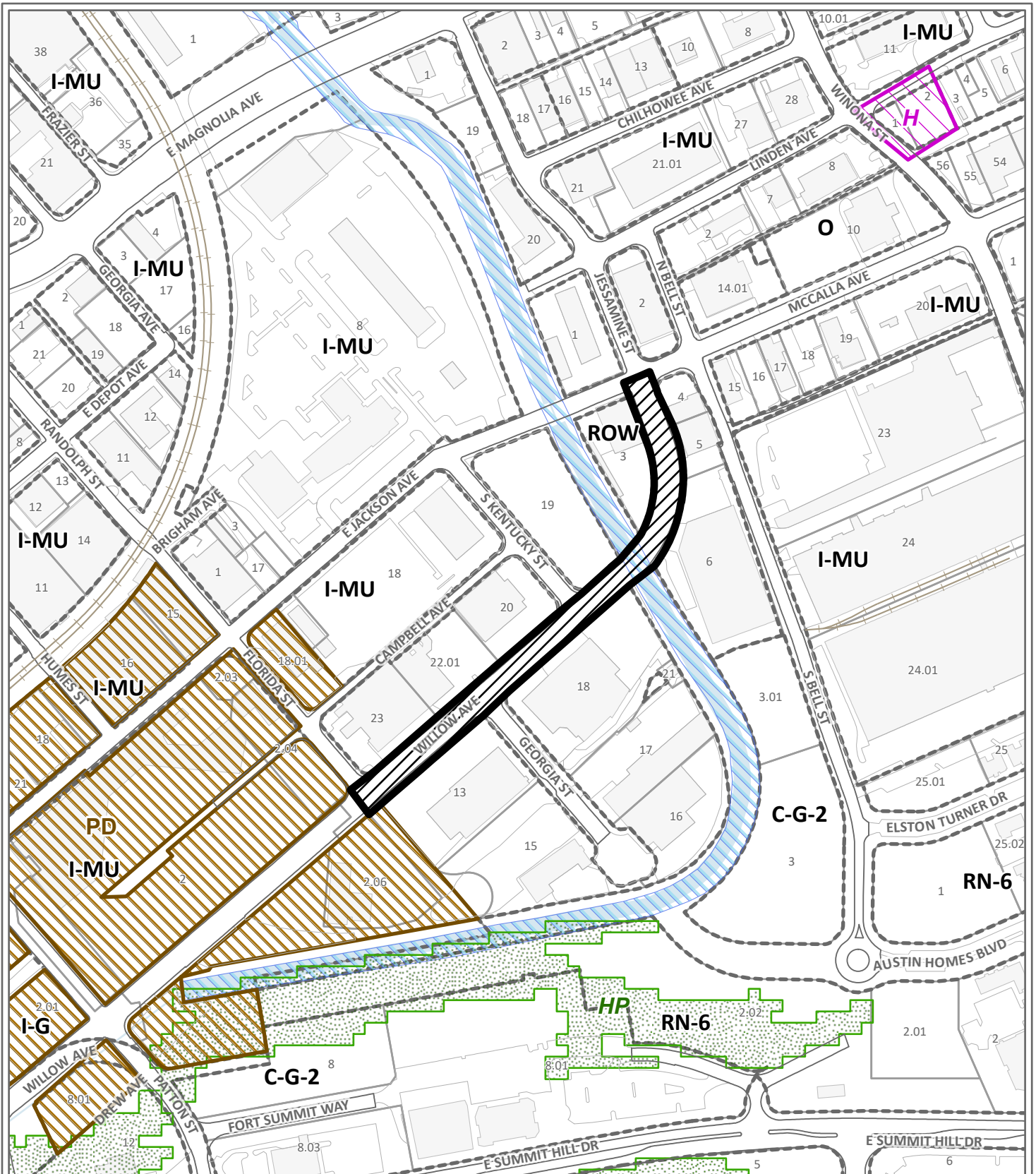
STAFF RECOMMENDATION:

► **Approve the street name change from Willow Avenue to Patton Street as requested by the City of Knoxville.**

COMMENTS:

1. The City of Knoxville has requested to change the street name of Willow Avenue to Patton Street. A portion of Willow Avenue was closed between Patton and Florida Streets (11-C-21-C), which caused the eastern and western portions of this right-of-way to be disconnected. Having non-contiguous road segments does not comply with the City of Knoxville's Street Naming and Addressing Ordinance.
2. The construction of the new Multi-Use Stadium established a new terminus at Florida Street for this section of Willow Avenue. This proposal is to rename the section of Willow Avenue, between Florida Street and McCalla Avenue, to Patton Street. The name "Patton Street" was selected to retain a historic street name in this community.
3. Planning mailed informational letters to all property owners impacted by the name change, notifying them of the proposed name change. The proposed street name change from Willow Avenue to Patton Street will impact approximately 7 businesses and a 35-unit multi-family complex.
4. The name change meets the City of Knoxville's Code of Ordinances Street Name and Addressing requirements, Chapter 23, Article IV, Section 23-108.

If approved, this item will be forwarded to Knoxville City Council for action on 2/4/2025 and 2/18/2025. If denied, Knoxville-Knox County Planning Commission's action is final, unless the action to deny is appealed to Knoxville City Council. The date of the appeal hearing will depend on when the appeal application is filed. Appellants have 15 days to appeal a Planning Commission decision in the City.

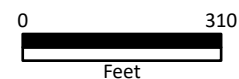
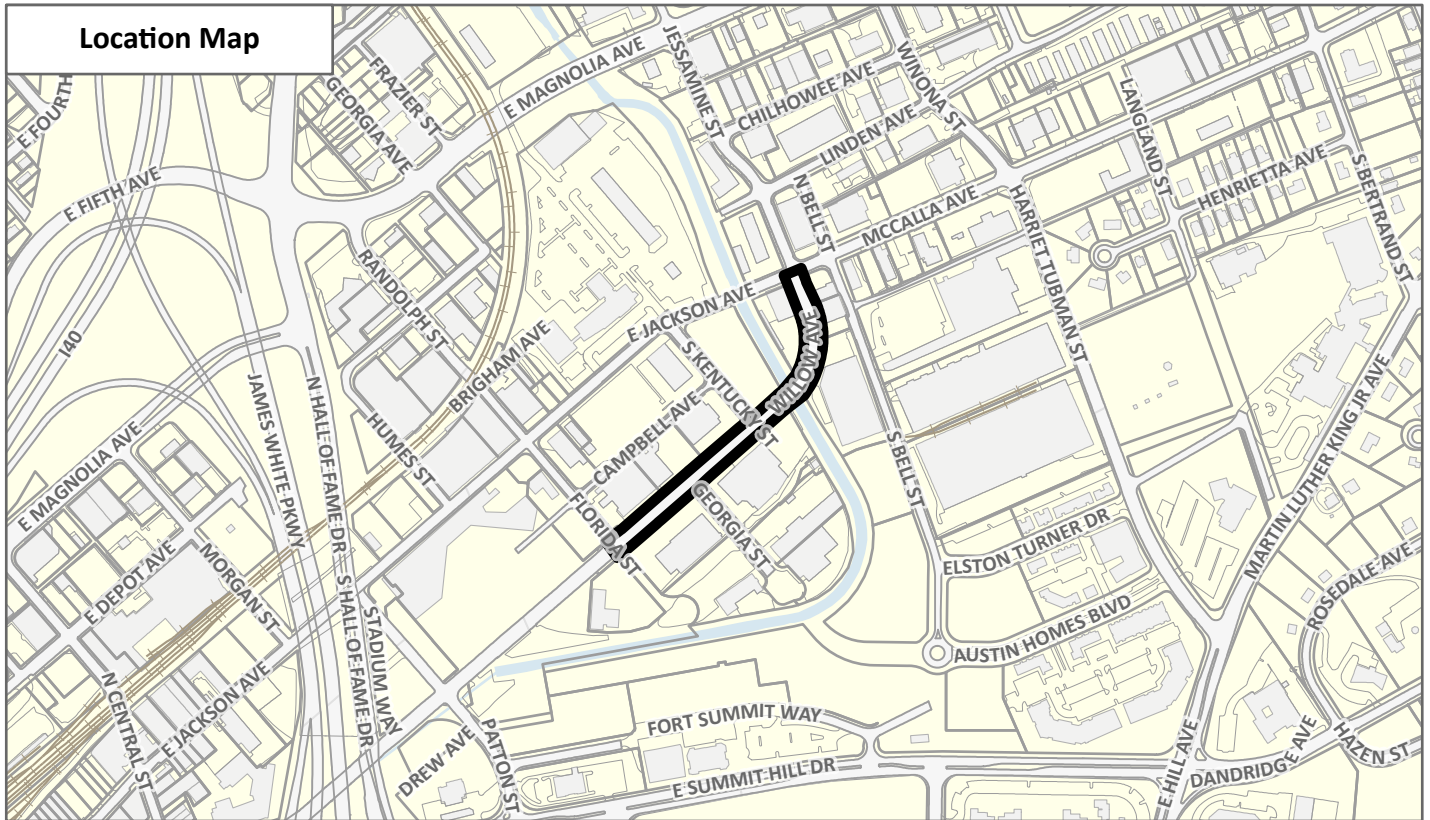

Aerial Map

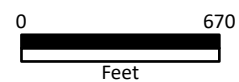


CONTEXTUAL MAPS 1



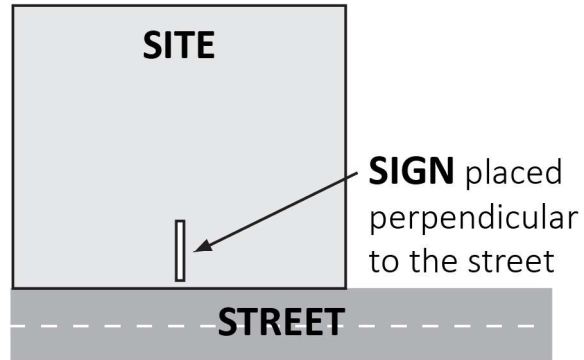

The Administrative Rules and Procedures of the Knoxville-Knox County Planning Commission require a sign to be posted on the property for each application subject to consideration by the Planning Commission, including the following applications: rezoning, plan amendment, concept plan, use on review/special use, planned development, right-of-way closure, and name change.



The required public notice sign(s) will be provided by Planning to the applicant when an application is submitted. If an application is submitted electronically, Planning staff will post the required sign. If a replacement sign(s) is needed, the applicant is responsible for picking up the new sign(s) from Planning and will be charged \$10 for each replacement.

LOCATION AND VISIBILITY

The sign must be posted on the nearest adjacent/frontage street and in a location clearly visible to vehicles traveling in either direction. If the property has more than one street frontage, the sign should be placed along the street that carries more traffic. Planning staff may recommend a preferred location for the sign to be posted at the time of application.

TIMING

The sign(s) must be posted **not less than 12 days prior to the scheduled Planning Commission public hearing** and must remain in place until the day after the meeting. In the case of a postponement, the sign can either remain in place or be removed and reposted not less than 12 days prior to the next Planning Commission meeting. The applicant is responsible for removing the sign after the application has been acted upon by the Planning Commission.
