AMENDMENT

THIS AMENDMENT to Document No. C-24-0069 is made by and between the **City of Knoxville**, a municipal corporation organized and existing under the laws of the State of Tennessee, P.O. Box 1631, Knoxville, Tennessee 37901 (“**City**”), and **Foundation Systems Engineering, P.C.**, a Tennessee corporation, P.O. Box 9449, Knoxville, Tennessee 37940-0449 (“**Consultant**”).

WITNESSETH:

WHEREAS, the City and Consultant previously entered into an agreement to provide asphalt testing and inspection services for both phases of the City’s 2024 Resurfacing Program, known as Document No. C-24-0069 (the “**Agreement**”); and

WHEREAS, the Agreement provided for asphalt testing services to cover both phases of the City’s annual resurfacing program with the option to renew for two additional one-year terms; and

WHEREAS, the parties wish to exercise the first renewal option extending the agreement to November 30, 2025; and

WHEREAS, the contract was previously amended to increase the contract amount by Nine Thousand Nine Hundred and Fifty and 00/100 Dollars (\$9,950.00); and

WHEREAS, the parties now wish to amend the Agreement to increase the annual contract amount by Seven Thousand Six Hundred Fifty and 00/100 Dollars (\$7,650.00) for a new annual

amount not to exceed Forty-Five Thousand and 00/100 Dollars (\$45,000.00) to provide for anticipated tests needed for this year and the future renewal.

NOW, THEREFORE, the City and the Consultant, for the mutual considerations stated herein, agree to modify Document No. C-24-0069 as follows:

1. The Agreement is hereby amended to extend the term for one year through November 30, 2025.

3. The annual contract price is increased to an annual amount not to exceed Forty-Five Thousand and 00/100 Dollars (\$45,000.00).

WITH THE EXCEPTION OF THE ABOVE-SPECIFIED MODIFICATIONS, ALL OTHER ARTICLES OF SAID ORIGINAL AGREEMENT AND ANY PREVIOUS AMENDMENTS THERETO WILL REMAIN IN FULL FORCE AND EFFECT.
