**WHEREAS**, the Knoxville-Knox County Planning Commission was formally created in 1956 pursuant to a resolution adopted by the Tennessee State Planning Commission (now the Tennessee Department of Economic and Community Development) under its authority granted by TENN. CODE ANN. §13-3-101, *et seq.*; and

**WHEREAS**, on September 16, 2014, City Council approved Resolution No. R-326-2014 authorizing the City of Knoxville (“the City”) to enter into an interlocal agreement with Knox County pertaining to the Knoxville-Knox County Planning Commission (“the Interlocal Agreement”); and

**WHEREAS**, the City and Knox County entered into said agreement October 3, 2014; and

**WHEREAS**, the Interlocal Agreement requires that seven (7) of the total fifteen (15) Planning Commissioners be nominated by the Mayor subject to confirmation by City Council,

for confirmation by the Tennessee Department of Economic and Community Development, or successor entity, as may be provided by general law; and

**WHEREAS**, the Mayor has nominated Marité Pérez and Margaret Butler, both contingent on state approval, to serve on the Knoxville-Knox County Planning Commission, said term to expire June 30, 2029; and

**WHEREAS**, City Council desires to confirm the Mayor's nominations.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF KNOXVILLE:**

**SECTION 1:** The Council of the City of Knoxville hereby confirms the following nominations, contingent on state approval, to the Knoxville-Knox County Planning Commission, said terms to begin July 1, 2025 and end June 30, 2029.
