At Hard Knox Pizza, we are committed to providing exceptional service to our guests while adhering to all applicable laws and regulations in the state of Tennessee. As a server, you play a critical role in ensuring that our establishment operates safely, responsibly, and in full compliance with the Tennessee Department of Health's Food Service Establishment Regulations, the Tennessee Alcoholic Beverage Commission (TABC) guidelines, federal labor laws under the Fair Labor Standards Act (FLSA), and workplace safety standards enforced by the Occupational Safety and Health Administration (OSHA). This document outlines the key "Do's" and "Don't's" to guide your conduct and help maintain our commitment to excellence and legality. Your attention to these guidelines ensures the safety of our guests, the well-being of our team, and the success of our business.

---

### Do's for Employees

#### 1. **\*\*Maintain Food Safety Standards\*\***

- Do wash your hands thoroughly with soap and water for at least 20 seconds before handling food, after using the restroom, and after touching any potentially contaminated surfaces. Tennessee health codes require strict hygiene to prevent foodborne illness.
- Do ensure all food served to guests is held at proper temperatures: hot foods at 140°F or warmer and cold foods at 41°F or colder. Use thermometers to verify temperatures when in doubt.
- Do store food properly when clearing tables or assisting in the kitchen—keep raw and cooked items separate to avoid cross-contamination, and refrigerate perishable items promptly.
- Do report any signs of spoilage, pest activity, or equipment malfunctions to management immediately to uphold our compliance with health inspections.

#### 2. **\*\*Serve Alcohol Responsibly\*\***

- Do check identification for every guest who appears under the age of 30 before serving alcohol, as required by Tennessee law. Acceptable IDs include a driver's license, passport, or military ID—ensure they are valid and not expired.
- Do familiarize yourself with the signs of intoxication (e.g., slurred speech, unsteady movements) and politely refuse service to anyone who appears overly intoxicated, in accordance with TABC regulations.
- Do keep accurate records of alcohol sales if requested by management, as this supports our liquor license compliance and responsible service practices.
- Do offer water, food, or non-alcoholic options to guests who may need to slow down their alcohol consumption—it's a courteous way to ensure their safety.

### 3. **\*\*Adhere to Wage and Tip Policies\*\***

- Do track your tips diligently and report them accurately to management each shift. Under the FLSA, Tennessee employers may take a tip credit of up to \$5.12 per hour, meaning your base wage may be \$2.13 per hour, but your total earnings (wages + tips) must equal at least the federal minimum wage of \$7.25 per hour.
- Do participate in any tip-pooling arrangements as outlined by management, ensuring tips are shared only with staff who customarily and regularly receive tips (e.g., servers, bussers, bartenders—not cooks or managers).
- Do notify management if you believe your wages plus tips fall short of the minimum wage, as employers are legally required to make up the difference.

### 4. **\*\*Promote a Safe and Respectful Workplace\*\***

- Do wear clean, presentable attire as specified by our dress code, ensuring you reflect the professionalism of Hard Knox Pizza. Tie back long hair and avoid loose jewelry that could pose a safety hazard.
- Do follow OSHA guidelines by keeping walkways clear of clutter, reporting spills immediately, and using caution when carrying hot or heavy items to prevent burns, falls, or injuries.
- Do treat all coworkers and guests with respect, adhering to anti-discrimination laws under Title VII of the Civil Rights Act and Tennessee statutes. Report any harassment or hostile behavior to management promptly.
- Do take breaks as scheduled to maintain your well-being, in line with Tennessee labor practices (though not legally mandated, we encourage reasonable rest periods).

### 5. **\*\*Enhance Guest Experience within Guidelines\*\***

- Do greet guests warmly, explain menu items clearly, and accommodate reasonable requests while ensuring compliance with health and safety standards (e.g., no substitutions that compromise food safety).
- Do clear plates only after all guests at the table have finished eating, asking politely if they'd like additional items before removing anything.
- Do ensure that handwashing signs and other required notices are visible to guests and staff, reinforcing our commitment to hygiene.

### Dont's for Employees:

#### 1. **\*\*Avoid Food Safety Violations\*\***

- Don't handle food or beverages with unwashed hands or while ill—stay home if you're experiencing symptoms like fever, vomiting, or diarrhea, as required by Tennessee health regulations to prevent outbreaks.
- Don't leave perishable food out at room temperature for more than 2 hours (or 1 hour if the temperature exceeds 90°F), as this violates safe holding practices and risks guest health.

- Don't use the same utensils or cutting boards for raw and cooked foods without sanitizing them first—cross-contamination is a leading cause of health code violations.
- Don't ignore expired items or improperly stored food; always discard or report them rather than serving them to guests.

## 2. **\*\*Refrain from Irresponsible Alcohol Service\*\***

- Don't serve alcohol to anyone under 21, even if they're with an older group— Tennessee's strict liability laws hold servers and establishments accountable for underage drinking violations.
- Don't overserve guests who show signs of intoxication, as this could lead to liability under Tennessee's dram shop laws if they cause harm after leaving our premises.
- Don't consume alcohol on duty, even if offered by a guest—it's against TABC rules and our internal policy.
- Don't falsify alcohol sale records or bypass ID checks to speed up service; accuracy and diligence protect our liquor license.

## 3. **\*\*Steer Clear of Wage and Tip Missteps\*\***

- Don't withhold tips from coworkers eligible for tip pools or attempt to include ineligible staff (e.g., managers or back-of-house employees) in the distribution, as this violates FLSA rules.
- Don't assume mandatory service charges (e.g., for large parties) count as tips—these are wages under IRS rules, and misrepresenting them can lead to payroll errors.
- Don't fail to report your tips accurately; underreporting can trigger audits and penalties for both you and the restaurant.

## 4. **\*\*Avoid Workplace Safety and Conduct Issues\*\***

- Don't neglect to report workplace injuries or hazards (e.g., slippery floors, broken equipment) to management—OSHA compliance depends on proactive communication.
- Don't engage in or tolerate discrimination, harassment, or bullying, whether toward coworkers or guests—this breaches federal and state laws and our zero-tolerance policy.
- Don't rush through tasks in a way that endangers yourself or others, such as carrying too many plates or ignoring safety protocols for speed.
- Don't use personal phones excessively during shifts, as this distracts from guest service and safety awareness.

## 5. **\*\*Don't Compromise Guest Trust\*\***

- Don't bring the bill to the table before the guest requests it—let them enjoy their experience without feeling rushed, unless they signal otherwise.
- Don't argue with guests over menu items or policies; escalate concerns to management calmly to maintain professionalism and compliance with customer service expectations.
- Don't cut corners on cleanliness, such as reusing unwashed glassware or neglecting to wipe down tables thoroughly—guest health and satisfaction depend on diligence.
