Management of Work

- Carmichaels Lawn Care, LLC agrees to adhere to all terms listed in the “Mowing and Grounds Maintenance Services for Zone D” RFP.
- Carmichaels Lawn Care, LLC intends to perform 100% of the work outlined in the contract as a Women Owned Business certified by the Tennessee Governor's Office of Diversity Business Enterprise (GO-DBE). No subcontractor will be hired.
- Carmichaels Lawn Care, LLC is experienced and familiar with documenting completed service, and submitting the required “checklist” to the Horticulture Manager at the end of each cycle.
- Carmichaels Lawn Care, LLC is experienced and familiar with the City of Knoxville’s invoicing procedures and requirements.
- Carmichaels Lawn Care, LLC is currently compliant with all insurance requirements as stated in the “Mowing and Grounds Maintenance Services for Zone D” RFP. We agree to continue to maintain such insurance from the time services commence until services are completed.
- If awarded the contract for “Mowing and Grounds Maintenance Services for Zone D” RFP, Carmichaels Lawn Care, LLC intends to renew for all years available. In the event that the contract is extended, our company will extend the initial pricing proposed to the City of Knoxville without increase.

Proposed Sites

Mowing and Maintenance will be performed for the 30 Zone D sites outlined in the RFP.

Service / Cycles

Year-round service will be performed on a fourteen (14) calendar day cycle for a total of twenty six (26) cycles.

Mowing Cycles

- Sixteen (16) “Mowing Cycles” will be performed March 17th, 2025 to October 31st, 2025. (Per dates outlined in the RFP)
- Mowing Cycle service will include: mowing, weed eating, and edging; litter pickup/removal; brush, leaf, debris removal; blowing off grass, soil and debris from paved surfaces for each site following the specifications and requirements outlined in the RFP.

- All weed removal will be performed mechanically. Herbicide will **not** be used unless specifically requested by the Horticulture Manager.

Maintenance Cycles

- Ten (10) "Maintenance Cycles" will be performed November 1st 2025- March 14th 2026. (Per dates outlined in the RFP)
- Maintenance Cycle service will include: littering, cleaning up leaves and cutting out underbrush as well as repairing erosion problems, seed and straw.

Service Completion

- Service will be completed within the first 1-2 days of each fourteen (14) calendar day cycle.
- In the event of inclement weather, the schedule will immediately resume on the following day or as soon as weather/ground conditions improve, unless specifically instructed otherwise by the Horticulture Manager.
- Work will be performed Monday-Friday (Crews will be available to work on Saturday in the event of a weather delay). Work will **not** be performed on Sundays, unless specifically requested by the Horticulture Manager.
- Every cycle, the invoice and checklist documenting the service completion date(s) for each site will be submitted to the Horticulture Manager within one (1) day of completion via email.

Employees Performing Service

Safety

- All Carmichaels Lawn Care, LLC employees performing services under this contract will be safety certified.
- While performing services under this contract, all Carmichaels Lawn Care, LLC employees/representatives will be required to wear provided Personal Protective Equipment Protective Equipment including: all required safety clothing, masks, eye and ear protection, footwear, etc., as required by law, regulation, ordinance, and/or manufacturer's instructions for material and as required/recommended by OSHA and DOT.
- All equipment used by any Carmichaels Lawn Care, LLC employee/representatives will be commercial grade, in proper working condition, and professionally enhanced for safety.

Uniform

Our company understands that the appearance of the Zone D sites are a reflection of the City of Knoxville. It is our priority to ensure that the sites are maintained to the highest standards at all times. To ensure the highest quality of maintenance, our company will be available for on-call services in the event that an unforeseen maintenance issue arises within the 14 day cycle (I.E.: A fallen limb needs to be removed.) We will send a crew out to take care of it immediately, rather than waiting for the next cycle.
