1. I/we Beyron Tejedo Pardo hereby solemnly swear or affirm that each statement in this application is true and correct and understand that if any statement contained herein is false, the permit issued is automatically forfeited and voided. Furthermore, that in the event of forfeiture I/we shall not be eligible to receive another permit for a period of ten (10) years pursuant to Tennessee Code Annotated § 57-5-105(d).
2. I/we understand that all applicants are charged with the responsibility of knowing the local and state beer laws. I/we are aware that the penalty for violating state or local beer laws can include revocation or suspension of the permit and/or the imposition of civil penalties up to ONE THOUSAND FIVE HUNDRED 00/100 DOLLARS (\$1,500.00) PER OFFENSE.
3. I/we understand that if the business allows illegal gambling on the premises that the beer permit will be subject to revocation.
4. I/we understand that a requirement of beer permit issuance is the permittee(s) and ON-SITE manager(s) who will supervise and/or sell and serve the beer at the establishment must complete alcohol education and training programs in accordance with City of Knoxville Code Section 4-60(c).
5. I/we understand that by submitting this application, a background investigation shall be conducted on the applicant(s) and on all ON-SITE managers who will be selling beer at the permitted establishment. It is further understood that any and all documents related to that investigation shall become public record open for public inspection and reproduction pursuant to Tennessee Code Annotated § 10-7-503.
6. I/we understand that a requirement of maintaining good status standing with the Knoxville Beer Board, is that I/we must notify the City of Knoxville Business Tax Office each time there is a change in the on-site manager responsible for selling the beer.
7. I/we hereby release, absolve and hold harmless, the City of Knoxville, the Knoxville Beer Board, the Knoxville Police Department, its employees, agents and representatives from any and all liability of whatever type for any damages, causes of actions, personal property injuries which may result as a consequence of my application for a beer permit, background investigation, release of documents or any other matters related to my application. I/we hereby waive all possible liability of the City of Knoxville, Knoxville Beer Board, Knoxville Police Department, its employees, agents and representative as stated above.
8. I/we agree that the hiring of an employee who has been convicted within the past ten (10) years of any law relating to the sale, possession, manufacture or transportation of intoxicating beverages, including beer, as defined by City of Knoxville Code Section 4-37 or the hiring of an employee who has been convicted of any felony or crime involving moral turpitude within the past ten (10) years will be cause for possible revocation of the beer permit.
9. I/we understand if any information given in the application subsequently changes, I/we will immediately notify the Knoxville Beer Board c/o Business Tax Office.
10. I/we understand that if the business closes down, relocates, or there is ANY change in the ownership of the business, the permit will be surrendered to the Business Tax office within 15 days of said change for appropriate action.
11. I/we assume full responsibility for the permit and will be accountable for full compliance with the laws of Knoxville and the State of Tennessee in the sale of beer.
12. I/we have read the foregoing release. I/we fully understand its provisions, and voluntarily consent to abide by its requirements.
13. I/we acknowledge and understand that the fees paid for the beer permit application process are non-refundable.

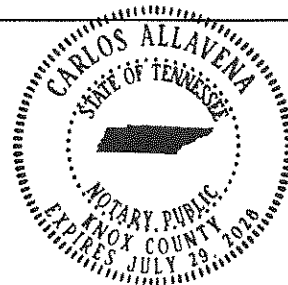

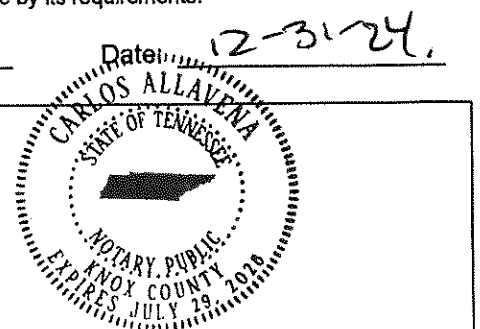

Serve Plan and Alcohol Policy for Knoxville Sport Bar And Lounge

Objective

To create a safe, enjoyable, and responsible drinking environment for patrons while complying with state and local laws regarding the service of alcoholic beverages.

Serve Plan

1. Staff Training and Certification

- **Required Certifications:**
 - All servers and bartenders must complete a state-approved responsible beverage service training program (e.g., TABC in Tennessee).
 - Certification must be renewed as required by state law.
- **Ongoing Training:**
 - Monthly in-house training on responsible serving practices, recognizing fake IDs, and dealing with intoxicated customers.
 - Emergency protocols training for handling incidents.

2. Age Verification

- **Policy:**
 - No alcohol will be served without verifying the age of the patron using a valid government-issued photo ID.
- **Procedure:**
 - Check all IDs to verify customers' age before alcohol is purchased.
 - Use an ID scanner to ensure authenticity when available.

3. Responsible Serving Practices

- **Drink Limits:**
 - Limit customers to one drink per ID at a time during busy hours or high-risk events.
- **Alcohol Awareness:**
 - Monitor customers for signs of intoxication and refuse service if necessary.
 - Offer water or non-alcoholic alternatives to individuals showing signs of impairment.
- **Promotion Rules:**
 - Prohibit extreme drink specials like unlimited drinks for a fixed price or shots contests.
 - Promote food and non-alcoholic drink pairings during alcohol promotions.

4. Incident Documentation

- **Procedure:**
 - Maintain an incident log to document refusals of service, altercations, or other alcohol-related issues.
 - Include the time, customer description, staff involved, and actions taken.

Alcohol Policy

1. Legal Compliance

- Adhere strictly to local, state, and federal laws regarding alcohol sales and service.
- Follow operating hours for alcohol service as defined by local ordinances.

2. Refusal of Service

- **Right to Refuse:**
 - Staff have the right to refuse service to any customer who appears intoxicated, behaves aggressively, or attempts to purchase alcohol for minors.
- **Procedure:**
 - Politely explain the reason for refusal and offer alternative beverages or assistance (e.g., calling a cab).

3. Safety Measures

- **Transportation Assistance:**
 - Partner with local ride-sharing services or taxi companies to provide safe transportation for customers.
- **Designated Driver Program:**
 - Offer free non-alcoholic beverages to designated drivers in a party.

4. Zero Tolerance for Underage Drinking

- Staff found serving alcohol to minors will face immediate disciplinary action, including potential termination.
- Customers using fake IDs will be reported to local authorities and denied entry.

5. Conflict Management

- **De-Escalation Training:**
 - Staff will be trained to handle disputes, aggressive behavior, or intoxicated patrons calmly and effectively.
 - **Security Measures:**
 - Employ trained security personnel during high-traffic events, such as sports games or weekend evenings.

Implementation and Monitoring

- **Policy Distribution:**
 - Provide all employees with a copy of the Serve Plan and Alcohol Policy during onboarding.
- **Regular Audits:**
 - Conduct bi-monthly checks to ensure compliance with the policy.
- **Customer Feedback:**
 - Encourage patrons to provide feedback on their experience to identify areas for improvement.
