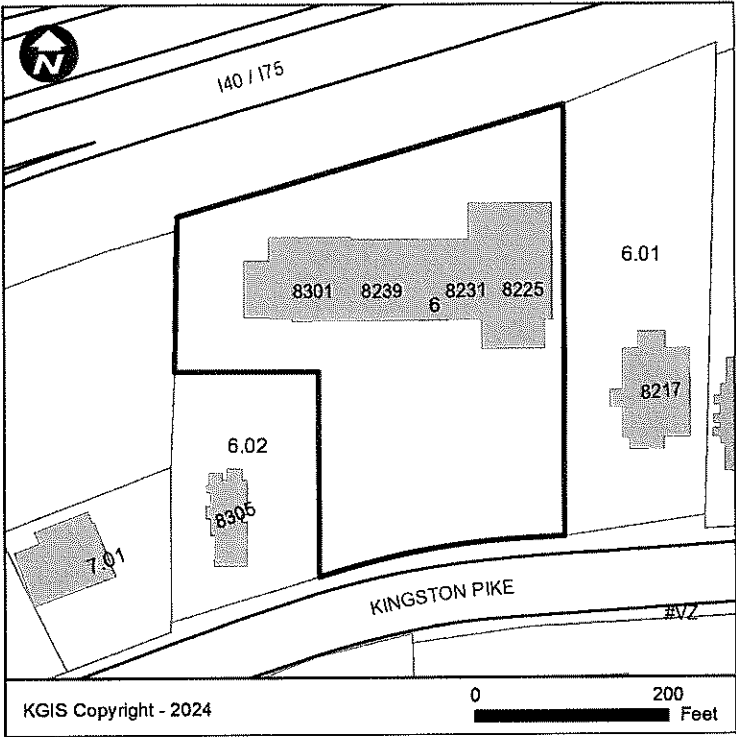

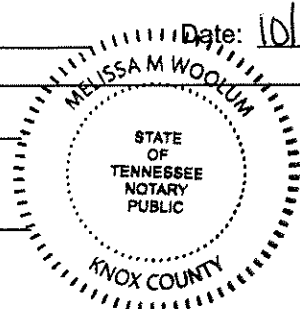

Furthermore, that in the event of forfeiture I/we shall not be eligible to receive another permit for a period of ten (10) years pursuant to Tennessee Code Annotated § 57-5-105(d).
2. I/we understand that all applicants are charged with the responsibility of knowing the local and state beer laws. I/we are aware that the penalty for violating state or local beer laws can include revocation or suspension of the permit and/or the imposition of civil penalties up to ONE THOUSAND FIVE HUNDRED 00/100 DOLLARS (\$1,500.00) PER OFFENSE.
3. I/we understand that if the business allows illegal gambling on the premises that the beer permit will be subject to revocation.
4. I/we understand that a requirement of beer permit issuance is the permittee(s) and ON-SITE manager(s) who will supervise and/or sell and serve the beer at the establishment must complete alcohol education and training programs in accordance with City of Knoxville Code Section 4-60(c).
5. I/we understand that by submitting this application, a background investigation shall be conducted on the applicant(s) and on all ON-SITE managers who will be selling beer at the permitted establishment. It is further understood that any and all documents related to that investigation shall become public record open for public inspection and reproduction pursuant to Tennessee Code Annotated § 10-7-503.
6. I/we understand that a requirement of maintaining good status standing with the Knoxville Beer Board, is that I/we must notify the City of Knoxville Business Tax Office each time there is a change in the on-site manager responsible for selling the beer.
7. I/we hereby release, absolve and hold harmless, the City of Knoxville, the Knoxville Beer Board, the Knoxville Police Department, its employees, agents and representatives from any and all liability of whatever type for any damages, causes of actions, personal property injuries which may result as a consequence of my application for a beer permit, background investigation, release of documents or any other matters related to my application. I/we hereby waive all possible liability of the City of Knoxville, Knoxville Beer Board, Knoxville Police Department, its employees, agents and representative as stated above.
8. I/we agree that the hiring of an employee who has been convicted within the past ten (10) years of any law relating to the sale, possession, manufacture or transportation of intoxicating beverages, including beer, as defined by City of Knoxville Code Section 4-37 or the hiring of an employee who has been convicted of any felony or crime involving moral turpitude within the past ten (10) years will be cause for possible revocation of the beer permit.
9. I/we understand if any information given in the application subsequently changes, I/we will immediately notify the Knoxville Beer Board c/o Business Tax Office.
10. I/we understand that if the business closes down, relocates, or there is ANY change in the ownership of the business, the permit will be surrendered to the Business Tax office within 15 days of said change for appropriate action.
11. I/we assume full responsibility for the permit and will be accountable for full compliance with the laws of Knoxville and the State of Tennessee in the sale of beer.

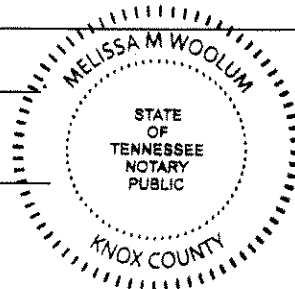

## **Responsible Alcohol Service**

One of the many attractions of our restaurant is atmosphere. The serving of alcohol is one of the elements that contributes to that atmosphere and to guest satisfaction.

Unfortunately, there are those who drink for the wrong reasons or who over consume alcohol. At times alcohol is not pleasurable. Studies show that on average, there is one alcohol related fatality every 31 minutes. Not only is the drunk driver at risk, many of those injured or killed are passengers or innocent bystanders.

Traffic accidents are not the only concern regarding alcohol consumption. Individuals may become hostile and start fights, causing injury to themselves or others. Due to poor judgement or reduced motor coordination, the person who has over-consumed alcohol may fall or be injured accidentally.

It is our responsibility to provide a safe, family-friendly environment for all of our guests. Safely serving alcohol is everyone's responsibility.

Any cashier or server must successfully complete Chuck E. Cheese's Responsible Alcohol Service training program prior to attempting to sell or serve alcohol, in addition to complying with any local laws and regulations.

*Responsible alcohol service can be as simple as 1, 2, 3.*

### VALID ID PER GUEST

Before attempting to serve alcohol, you must know the legal age and training requirements of your state to pour, sell, or serve alcohol.

At Chuck E. Cheese's, you must be at least 18 years of age to sell alcohol. Some states require you to be older. This means you cannot even hit the button on the register. A separate transaction must be rung up if alcohol is ordered and the cashier is not old enough to sell. In fact, in some states, you must be of legal age to even clear off cups that contain alcohol while bussing a table.

At Chuck E. Cheese's, it is the server's responsibility to check all IDs before serving alcohol. Even if a cashier already checked the ID, the server is responsible. Know the legal age and training requirements in your state prior to attempting to serve.

If you are of legal age to serve, it is your responsibility to make sure the guest is of legal drinking age – 21 to consume alcohol.

Some states allow decoy programs that send in underage people to buy alcohol. If the cashier fails to card that person, or if the cashier is underage, both the cashier and the manager could serve time in jail, as well as pay a fine.

In some states, it may be illegal for a minor to buy, or try to buy, alcohol. It may also be illegal for a minor to present a false ID. However, these restrictions vary from state to state. Even if it is not illegal in your area for a minor to present a false ID, or try to buy alcohol, it is illegal for you to serve a minor. You will be held accountable, even if you the minor is not!

If the guest is ordering at the cash register, the person serving the alcoholic beverage is responsible to ID the guest. At a party, the Party Server must direct the guest to the order counter or a tablet attendant that is old enough to sell alcohol.

To be sure the guests are old enough; you will need to start by checking the IDs of everyone, no matter how old they appear, and knowing which types of ID are valid.

### Acceptable Forms of Identification

All acceptable forms of identification require a photo and date of birth.

- ☒ Driver's license
- ☒ State-issued identification card
- ☒ Federal Military ID card
- ☒ US Passport & Foreign Passport

If someone does not have a valid ID, you may respond with, "I'm sorry, but I cannot serve you without a valid ID."

### **Checking Identification**

When validating an ID, use the **FLAG** system:

**Feel** – have the person remove the ID from their wallet and feel for information cutout or pasted on. Feel the texture.

**Look** – Look for the state seal, look at the photograph; hairstyle and eye color can be altered, so focus on the person's nose and chin. If the person has facial hair, cover the facial hair portion of the photo and concentrate on the nose or ears. Look at the height and weight. Look at the date of birth. Look at the expiration date, if it is expired, it is not acceptable.

**Ask** – Ask questions of the person. Ask them their middle name, or month they were born. Ask the person to sign their name, and then compare signatures.

**Give** – After validating the ID and recording or swiping the necessary information, give the ID back to the guest and finalize the transaction. If the ID is phony or altered, you should still return the ID. Only peace officers are authorized to seize false ID documents.

At Chuck E. Cheese's we have a 2 drink limit for our guests. This means, they may not be served more than 2 drinks in one day.




Blood Alcohol Content (BAC) is the amount of alcohol in someone's blood stream.

If a person drinks faster than his or her body can process the alcohol, it gets absorbed into the blood stream and begins taking effect.

In some states, .08 is the legal limit to get a DUI. How much does it take to reach those levels? It depends.

One drink equals twelve ounces of beer or a three-ounce glass of wine. A person who had two large beers or the equivalent of almost four drinks could be at .08 BAC. It is time to stop serving them. A good rule is no more than one drink per hour.

Therefore, it is important that our employees recognize signs of intoxication and understand how to handle the guest in a way that assures compliance with local laws.

Type of Drink	Amount of Alcohol	B.A.C. per Drink
Regular Beer 	12 oz serving 4% alcohol	.02
Red/White Wine Champagne 	3 oz serving 12% alcohol	.02
Hard Liquor, Whiskey, Vodka, etc. 	1 oz serving 45% alcohol	.02

### *Warning signs of intoxication*

- ☑ Alcohol reduces inhibitions: The guest may be overly friendly, speak too loudly, or annoy other people.
- ☑ Alcohol impairs judgement: The guest may use foul language, make irrational statements and be belligerent.
- ☑ Alcohol slows down reactions: The guest may have lack of eye focus, slurred speech, and glassy eyes.
- ☑ Alcohol hinders coordination: The guest may spill or drop things, stumble, or fall.

Remember, one of these behaviors might not mean a guest is intoxicated, but a combination of any is a definite warning sign. You should be able to recognize these signs of intoxication in guests.

#### *How to handle alcohol problems:*

Once it becomes obvious that a guest is intoxicated, it is your responsibility to refuse to serve them another drink. If you serve alcohol to a guest who is already intoxicated, you are breaking the law! The important thing to remember when cutting someone off is to be tactful and friendly, but assertive. Do not back down! Here are some key elements to remember when refusing service.

- ☑ **Wait until the guest asks for a drink before refusing service.** There is no use telling a guest of your decision to stop service unless the guest asks for another drink. Do not risk angering the guest by saying "This is the last drink for you tonight." Do not cut a guest off while he/she has a drink and is content. Wait until the guest asks for the next one.
- ☑ **Be friendly.** Introduce yourself if you have not done so previously. "Good evening. My name is Tom. Are you enjoying yourself this evening?" Do not approach a guest in a threatening or disapproving manner. Being friendly is the best practice.
- ☑ **Do not be judgmental.** Do not blame the guest for drinking too much. Do not say, "You're drunk." Your guest may have miscalculated and accidentally had one too many. Give your guest the benefit of the doubt. The guest will probably regret having had too much alcohol when his/her judgment is less impaired.
- ☑ **Do not embarrass your guest.** Avoid a public scene. Quietly tell the guest that you can no longer serve him/her alcohol. In some cases, it may be better to ask a guest to speak to you near the entrance.
- ☑ **Ask for help when necessary.** If one guest at a table has been drinking more heavily than his/her friends, ask a responsible person in the group to help you in offering the intoxicated guest something other than alcohol to drink. Use peer pressure whenever it might help.
- ☑ **Alert a backup.** When you discontinue service, tell the cashiers. Do not approach an intoxicated guest with the bad news of "no more alcohol" without having someone monitor the situation. The backup should be standing by, not approaching the guest with you. Two or more persons confronting the guest can be threatening.
- ☑ **Shift the blame.** The guest is less likely to get angry if the one to blame for his/her being cut off is not you, but the liquor code, or even the police. "I'm sorry, but my manager won't let me serve you another drink. It is the house policy. How about some coffee or iced tea?"
- ☑ **Offer alternatives to alcohol.** Cutting off service of alcohol is easier if you have alternatives to offer. Know what the alternatives are and whether they will be offered free or at a charge. "I'm sorry, I can't serve you any more alcohol at this time. May I bring you a cup of coffee and some breadsticks?"
- ☑ **Express your concern for the guest's wellbeing.** Resisting you is more difficult for the guest when you show concern for his/her welfare. The guest feels understood when you sympathize with him/her. "I'm sorry, but I can't serve you any more alcohol. We're concerned about you and want to make sure you get home safely and come visit us again."
- ☑ **Be firm.** Once you have told a guest you are cutting off service, do not change your mind. Do not allow the guest to bargain for "just one more." Stand by your decision. Be careful

not to let other guests at the table ruin your efforts by passing drinks to the guest who has been cut off.

- ☑ **Remain calm.** Losing your temper or becoming irritated will not benefit you. It only makes matters worse. Practice what you need to say, so you will be comfortable when you have to say it. If your guest becomes hostile or says offensive things to you, try to ignore it. Remember, he/she is intoxicated. Do not take the comments personally, and never lower yourself by making offensive comments in return. Of course, if the guest's offensiveness continues beyond a remark or two, state that the guest will be asked to leave.
- ☑ **Do not use physical force.** Do not touch a guest. If a guest becomes physically pushy, try to avoid him/her. If necessary, ask your backup to call the police.

*Preventing & avoiding potentially dangerous situations with alcohol:*

1. Actively encouraging patrons not to become intoxicated if they are consuming alcoholic beverages on the premises.
2. Promoting alternative, non-alcoholic beverages and making food readily available to patrons.
3. Providing an alternative, "safe" means of transportation intended to reduce the incidence of patrons driving while intoxicated.
4. Prohibiting employees from consuming alcoholic beverages while on duty.
5. A comprehensive on-going training program for servers in alcohol awareness, the responsible service of alcohol, and how to effectively interact with intoxicated patrons.
6. Maintaining an adequate number of well-trained employees for the type and size of the establishment.
7. Maintaining a standardized method for screening and hiring qualified employees.
8. Reprimanding and disciplining employees who violate the business's policies and procedures.
9. Establishing a comprehensive on-going training program for servers focusing on methods of detecting a falsified or altered piece of identification tendered for the purpose of purchasing alcoholic beverages.
10. Training servers to carefully examine identification for all persons seeking to purchase alcoholic beverages who may be reasonably suspected of being under aged.



If you serve three drinks to a guest, you can be terminated.

### **Server and Licensee Liability**

For one thing, selling alcohol to a minor or intoxicated person is a criminal offense throughout the United States. The potential legal consequence for servers include arrest, fine, jail term, criminal record, and loss of employment. In addition, as the holder of the establishment's liquor authority. The state also has discretionary power to suspend or revoke an establishment's license, effectively closing its doors.

Selling alcoholic beverages to an underage or obviously intoxicated person are not the only acts that create legal liability. A licensee also has a legal responsibility to ensure the safety and welfare of the establishment's clientele and can be held civilly and administratively liable for incidents occurring on the licensed property that result in bodily injury or property damage.

The servers, Managers, and the company can be liable for a guest's actions if he/she injures him/herself or another party as a result of becoming intoxicated in our restaurants.

The most prevalent type of liquor liability lawsuit is brought by an innocent "third party" injured in some manner by an intoxicated patron. In these cases, the plaintiff's attorney will attempt to prove that the patron was served alcohol to the point of intoxication, allowed to leave the establishment in an incapacitated condition and that the alcohol-induced impairment directly caused the ensuing accident. As a result of the employee's negligence, the licensee is culpable and liable for damages sustained by the third party.

A Manager may also be named as a defendant in a third party lawsuit based on the liability theory of negligent failure to supervise. The basis for the action stems from the theory that a Manager has a duty to "reasonably supervise and monitor" the on premise activity and the actions of the operation's employees.
